

Regina Catholic Schools Football – Equipment Loan Agreement / Acknowledgement

As a part of an agreement made with Regina Minor Football, players wishing to participate in the 2021 RMF Spring League may borrow equipment from Regina Catholic Schools. In signing below, players agree to the following conditions:

- In order to protect the overall quality and integrity of Regina Catholic Schools football equipment, a \$100 user fee is required to be paid before equipment is issued to students. Online payment through SchoolCash is acceptable. This is to cover the cost of cleaning and recertification.
- Regina Catholic Schools football equipment may not be altered in any way for any reason.
- Any temporary alterations (attaching a visor or back plate for instance) should be done with permission of the head football coach at the specific school. Any and all alterations must be installed by a qualified coach or qualified equipment manager.
- All Regina Catholic Schools football equipment must be returned in the same condition in which it was loaned. All equipment must be sanitized and inspected and certified for safety both before and after your usage (arranged by the coach at the school).
- Equipment should only be used in supervised situations with RMF trained coaches and any liability insurance will go through Regina Minor Football and their membership with Football Saskatchewan.
- While wearing this equipment, you are representing Michael A. Riffel Catholic High School and should conduct yourself with the utmost respect. (hint: team helmets with school logos on them are easy to spot so you will be easy to identify).
- The maximum length of time Regina Catholic Schools football equipment can be used is for the duration of the Spring Season. Upon completion of the season, it must be returned immediately, or an additional fee will be added to the school fees to cover the total cost of replacement.
- Football practices, drills, and competitions come with inherent risk. With proper technique and care, players can avoid injury. However, if an injury does occur, the school, Regina Catholic School division, and coaches are not liable for damages. All claims would need to be against Regina Minor Football.
